Road and Recreation

THANK YOU to all involved in the positive conclusion to the Elk Wildfire.

With the snow, it is time for a reminder about our roads. Those coming UP an incline have the right-of-way to avoid loss of traction. Please be considerate of your neighbors. Maybe you will be trying to climb up the next time.

Speaking of consideration, THANK YOU! to those who are observing our reduced speed limit of 20 mph, unless posted otherwise. This helps our road team maintain driving conditions. For those of you who continue to drive above the limit, SLOW DOWN! I have observed and experienced crowding at switchbacks, corners, and intersections. The roads are narrow in places and taking your lane out of the middle can cause unnecessary avoidance reactions on the part of other drivers. PLEASE SLOW DOWN! Road & Recreation Association dues are reasonable now, but if we do not slow down, we may experience increased costs. Our roads belong to ALL of us, please be considerate of your neighbors.

As our community experiences continuing development, our roads may experience increased traffic. Again, slowing down reduces maintenance and friction between vehicles on our mountain roads. The orderly "build out" of our community will be enhanced by considerate members.

Water and Sewer

There was a good article in the last Viewpoint about what to do to help minimize water problems in freezing weather.

One thing I would like to add – the article said to turn off the valve into your hot water tank – and that is good. However, if you have an electric hot water tank, the water level in that tank can fall below the upper heat element when the rest of the house is drained. When turning on the water again in the Spring, or the next day, do not turn on the electricity to the house or to that hot water tank until you are sure that tank is completely full (water will run out of a hot water faucet when the tank is full). If the electricity is on before that tank is full, it only takes about 2 seconds to burn out the upper heat element. Guess what? You will have no hot water – and if you don't know how to replace the element, you may have a plumbing bill to pay.

I cannot emphasize enough to turn off your water supply — even if it is just overnight that you will be gone. The rule seems to be that water pipes only leak when you are not there.

Now – turn on a faucet and fill a one-gallon jug and see if it takes 2 minutes or less. Ok now leave that faucet run for 8 to 10 hours (the minimal time you are gone overnight). Ok take all that water (approximately 300 gallons) and dump it out on a kitchen or bathroom floor! Don't wipe it up – let it soak in! What kind of water damage do you think you will have when you get home?!!

Something else to do is put RV antifreeze in all drain lines and "P" traps when leaving for extended periods. Yes – blowing out all lines is good but you need to have liquid in "P" traps to prevent back flow of sewer gases into the home. That's where you need to have the RV antifreeze. This includes all sinks – dishwasher drains – clothes washer drains – floor drains – shower drains and all toilets and any other drains I may have forgotten.

Of course, "you say" I keep the heat on in my house at 50 degrees when we are gone! Ok – now what if the power is off for say 2 days and the temperature is 0-10 degrees for 2 nights and the daytime temperature is no more than 25 degrees. There is no heat system that I know of that operates without electricity. Do you want to take a chance with your home when all it takes is to do the proper sequence of water off and draining and antifreeze?

Insurance companies have a lot of records of water damage claims due to frozen pipes – and that does not consider your inconvenience of repairs!

Manager's Notes

Questions that come up about Snow Plowing in GVM

Yes, to some of you this is repetitive information, but for others it may be a refresher or completely new.

When snow is removed from a roadway, the snowplow operator piles it as far as possible off the road and may include a portion of your driveway where it connects to the road. To avoid placing a berm across the end of your driveway, our drivers would need to angle the blade at each driveway, which would cause a delay in snow removal and put some snow back onto the road. This would significantly increase the time required for snow removal. While we regret this inconvenience, our primary responsibility is to provide safe and reliable roadways for all who use GVM roads, including fire equipment, ambulance and law enforcement vehicles.

I live on a Court. Why does it take so long for my road to get plowed? The snowplow program is prioritized on a "greatest impact" basis. The main roads are plowed first, followed by less used roads and courts. This allows some mobility within the community and keeps emergency services as open as possible. What if I have an emergency and can't get out of my home? In the event of an emergency, always call **911**. Once these routes are accessible, courts and cul-de-sacs are plowed. With quick and heavy snowfall, it may be necessary for the snowplow to remain on the main roads for longer periods of time to keep up with the snow, which can cause a significant delay in getting to the secondary roads.

The snowplow sometimes hits my address sign. Why does this happen?

The Associations right-of-way often extends 30 feet out from the center of the road. To prepare for additional snow from the next storm, the snowplow operator pushes the snow as far off the road (and into the right-of-way) as possible. In the process, if address signs and posts are in the right of-way, and the operator does not see them. We suggest you place the metal signpost back as far as possible. The Association appreciates residents not building anything, including fences, or landscaping in the County's right- of-way, and keeping a minimum of 10 feet clear from the edge of the

Why can't I park on the roads in the winter? All motor vehicles and trailers should be kept clear of the roads to expedite snow removal operations and prevent damage to snowplows or private vehicles.

How far off the road do I need to park?

Ideally, the snowplow operator needs at least 10 feet to be clear on the side of the road. Anything less can cause a delay in snow plowing, possible damage to the plow or vehicle. How can residents help during the snow season? • Prepare for the snow season—get the necessary equipment, including snow shovels, snow blower and tire chains in the event of a heavy snowfall. If you can, please help your neighbors who are elderly or disabled by shoveling their driveway and berm.

Dogs Rule or Dog Rules?

The old saw that states, "There are no bad dogs, only bad dog owners" bears repeating, due to nuisance complaints of dogs running loose and aggressive dogs on GVM roads. Frequent postings on Next Door involve lost dogs and dogs that have run off. What is the solution for these recurring problems?

The general rule on animals within GVM is found in section 4.2 of the Master Declaration of GVM covenants:

No animals, livestock, or poultry ${\bf of}$ ${\bf any}$ ${\bf kind}$ shall be housed, raised or kept on any lot, either temporarily or permanently . .

There are three exceptions. First, "commonly accepted domestic household pets" are permitted

"provided they are not kept or maintained for any commercial purposes and are not a nuisance to adjoining property owners."

The second exception expands the first, and relates to dogs:

"Dogs may be kept **upon the premises** so long as they are securely confined in an enclosure such as a pen, restricted by a suitable leash or chain or having been **properly trained are at all times** within the control of the owner under voice command and **are not running at large**."

The third exception is that (2) horses may be kept in certain designated GVM lot filings.

The first common sense solution is a dog run fence. The second common sense solution is a leash. Dogs will be dogs. If an unconfined dog sees wildlife, it may be unreasonable to expect it not to chase, even it has been trained to follow voice commands.

Technically, covenant 4.2 does not actually permit residents to take their dogs on walks of GVM roads. However, this limitation has not been enforced, and probably won't be unless uncontrolled dogs running at large become more of a problem.

Dog owners: please be a good dog owner and keep your dogs under control and not a nuisance. Nuisance dog complaints received by the GVM office typically result in a gentle reminder to the owner. Multiple or serious complaints involving dogs at large being aggressive to other dogs or humans, or chasing wildlife, may be reported to Larimer County animal control or the local wildlife officer.

Tire chains are an amazing invention. They have been around for many years and have gotten thousands of people safely through horrible road conditions. The benefits of using chains are so clear that the state of Colorado has laws that require them on certain roads during poor road conditions. These laws are meant to protect drivers and all other vehicles on the road. Also, by requiring tire chains, the road crews can spend more time working on the road rather than working to avoid abandoned or stuck vehicles.

It's important to install chains in a safe, convenient area. Many people wait until they get stuck and find the job to much more difficult or impossible. Many residents, men and women alike, have been seen at the GVM gates "chaining up" before driving the last stretch home. These folks enjoy tremendous traction and a feeling of confidence all the way home. In the morning, they simply drive back down to the main road and remove the chains which takes even less time.

COVENANT QUICKIES

Did You Know?
Per The GVM Master Declaration covenant 4.3 - Duties of the Architectural Control Committee: No building shall be erected or altered until the construction plans and specifications regarding quality of workmanship, type of materials and harmony of external design shall have been approved by the Architectural Control Committee. (Please contact the office or visit the website to learn how to comply with this rule before you begin any construction)

Per The GVM Architectural Review Committee Rules, Section VI, other Environmental Rules Regarding Properties:

A. Exterior Lighting
In keeping with the natural setting in Glacier View Meadows, outside lighting should be limited. Short-term activation of lights by sensors is recommended, as is the use of low voltage (low candlepower) lighting systems. Automatic day-night activation by sensors or timers, resulting in extended night flood lighting is unacceptable. (Cov. 4.17) This nuisance is one which draws a fair number of complaints. Please turn off your outside lights when you go to bed at night.

ROAD & RECREATION BOARD ALLOCATION OF FUNDS

During the past years a combination of events, primarily savings resulting from light snowfall seasons, the R&R Association has accrued a sum of \$160,335 in cash balances in its operating checking account. Please understand that these funds are unrelated to monies that the Association has put aside in a Capital Reserve Account to provide for future office, building, equipment and vehicle replacement.

The Association Board of Directors at its September 18th meeting considered the use of the funds and the following amounts were approved.

- \$25,000 increase in the 2019-2020 budget for road maintenance and repair. The increased funds will provide for road grading, placing of road gravel, and for increased ditch maintenance. Also, for consideration of individual culvert installations. \$24,000 for the replacement of the tractor/mower used for grass mowing and road maintenance. \$25,000 for the cost of installation of a pavilion across from the Mountain Meeting Place. This permanent facility will replace the
- use of tents and provide for both Association and private party events.
- \$5,250 for repairs to the office building of water damage caused by a failed sump pump. The Water & Sewer Board will be contributing a similar amount for its share of the repair cost.
- \$50,000 increase in the 2019-2020 budget for the Capital Reserve Account. The Reserve Account consists of funds to be used primarily for the purchase of vehicles and equipment. At June 30, 2019, the end of the last fiscal year, The Capital Reserve Account had a balance of \$111,654. The budget for the current year called for \$40,000 to be contributed to the reserve. The additional contribution \$50,000 will result in a total reserve of \$201,000.

 These allocations of funds will leave \$31,185 to be maintained in the Association's Operating Account.

GLACIER VIEW MEADOWS POLICY FOR COLLECTION OF UNPAID ASSESSMENTS

Policy Purpose.

The purpose of this Policy is to emphasize that collection of unpaid Assessments is an important part of governing the Association and such collection must be done in a uniform manner in accordance with the Association Documents and CCIOA. It is the intent of this Policy to provide a framework for the collection of past due Assessments in a timely and efficient manner.

Collection of Unpaid Assessments.

To assist with the collection of unpaid Assessments in a timely and efficient manner, the Association shall do the following:

- a. If payment is not received within 30 days of the due date, the Association shall send a letter demanding payment to any delinquent Owner within 30 days after such annual Assessment becomes past due. The demand letter shall be mailed by regular United States mail within 30 days and will notify the Owner of the delinquency and associated late fees and demand payment within 30 days.
- b. In the event payment is not received from any delinquent Owner within 30 days after the date of the demand letter referenced above, the Association may pursue any one or all of the following collection remedies:
 - i. File an Assessment lien against the delinquent Owner's property.
 - ii. Commence and maintain legal proceedings (lawsuits seeking personal judgments and foreclosure actions) for the recovery of delinquent Assessments, late fees, interest, attorney fees and costs as may be allowed by the Association Documents or CCIOA.
 - iii. Pursue collection of judgments obtained against Owners.
 - iv. Take all other lawful action necessary to collect delinquent Assessments in accordance with the Association Documents and Colorado law.

If the Association fails to follow the procedures set forth above it shall not be construed as any waiver or release of a delinquent Owner's obligation to pay Assessments or the Association's right to collect the Assessments in accordance with the Association Documents and CCIOA.

Association's Attorney Fees and Costs.

Any delinquent Owner shall be responsible for attorney fees and costs incurred by the Association in the collection of past due Assessments, whether or not a lawsuit is commenced, in accordance with the Association Documents and CCIOA.

Foreclosure and Bankruptcy Notices.

If the Association receives any bankruptcy or foreclosure notice regarding an Owner with unpaid Assessments, the Association may seek advice from its attorney regarding the appropriate action to be taken. If the Association, through its attorney, has sent a demand letter, filed a lien or commenced legal proceedings against an Owner in order to collect unpaid Assessments, the Association shall forward any bankruptcy or foreclosure notice received to the attorney.

A reminder to those GVM residents that don't follow the rules of the extended parking of RV trailers and nonoperating cars on residential lots.



We are doing all we can to handle any complaints regarding this issue. A common question is why aren't we moving them out? GVM staff has no legal right to physically move these vehicles, but we do have legal rights to take actions. Several letters have been sent out notifying property owners of violations. If the property owner fails to follow up with action, then fines are imposed. I will do all I can to help any resident with issues or problems. Let's keep GVM a wonderful place to live and be a part of. As always please contact the office or me by phone or email with concerns or general questions, that is why we are here. 

LETA911 tips

Oct 29, 2019



If you do not have a dependable cell phone signal at your home, it is highly recommended that you have a landline with at least one old-fashioned wired phone that is plugged directly into the wall jack. A portable phone that has a base station and plugs into AC power will not work if there is a power outage unless you have it plugged into an Uninterruptible Power Supply (UPS). (a surge protector is not sufficient).

Follow these steps to receive text alerts anywhere in Larimer County:

Start a new text message to the number "888777" Enter "LETA" or "Go LETA" in the text message box Push the Send button

Receive the welcome message that confirms your registration

LETA911 sends notices that are "imminent threat to life". That includes **mandatory** or **voluntary** evacuation orders.

Note that the initial notice might be mandatory and later changed to voluntary. There are no guarantees that the LETA911 notice will reach you so use your own situational awareness and leave if you feel you need to.

The Sheriff's Emergency Services is the authority for issuing orders for wildfire and flood emergencies.

The LETA911 caller id is 970-658-2244. Add that to each of your device's/phone's contact list so that you don't mistake it for a regular unsolicited robocall.

You can call that 658-2244 number back and hear a recording of the message. Call Larimer Emergency Services at 498-5500 to reach a live person to talk with about the situation.

You can request a test of your device and/or get answers to your questions by calling 970-962-2173 or sending an email to letastaff@leta911.org

If you have a No Solicitation service, set up 970-658-2244 as a privileged caller. If your service does not have a privileged caller feature, you must remove the service in order to receive alerts from LETA911.

If your contact information (email, cell, phone) changes, you must update your information at leta911.org.

Ecology article for winter 2019 ViewpointNov 3, 2019

Here's a summary of the ecology committee's 2019 season:

A new trail was created – the Longview Trail with the Bear Caves Loop! The Overlook sign points to a spot with awesome views in all directions. Its trailhead is in filing 2 off Iron Mountain Dr just before Mt Guero Ct. That brings the number of trails to nine. Thanks to trail volunteers, all trails were cleaned up and several fallen trees were removed from the trails.

The backpack sprayers loaner program will be available again next spring. Not only can the sprayers be used for treatment of noxious weeds, but this year we included cheatgrass in the fall. Our partnership with Larimer Weed District provides chemicals at a reduced price in quantities suitable for individuals.

The predominant threat to trees is the IPS beetle. Remove all piles of slash or brush from your property – that is where they reproduce. That is also important for reducing fire fuels.

We hosted 7 informational presentations in this, the fourth season, of the Speaker Series. If you missed any of them, recordings

are available on the website.

64 nesting boxes for Mountain Bluebirds were distributed, with more to come next year.

A half-dozen new plants were added to the Demo Garden. Visit there to learn more about rainwater collection systems. Six articles were added to the website and a nature scavenger hunt document written.

We wrapped up the 2019 season with a dinner/get together in early October.


